As discussed we are in the process of discussing lease arrangements with Powerwater to utilise a section of their land at the Tennant Creek treatment facility to store pipe to be used for the NGP project.

Timeframe of operations is approximately 1 year from 1st Sept 16 to 1st Sept 17.

Pipe would be loaded into the yard from Oct 16 at 7 extendable trailer loads per day Monday to Saturday.

Pipe would be loaded out to the construction Right Of Way at the rate of approx 10-15 trailers per day during the pipe stringing phase of the project.
