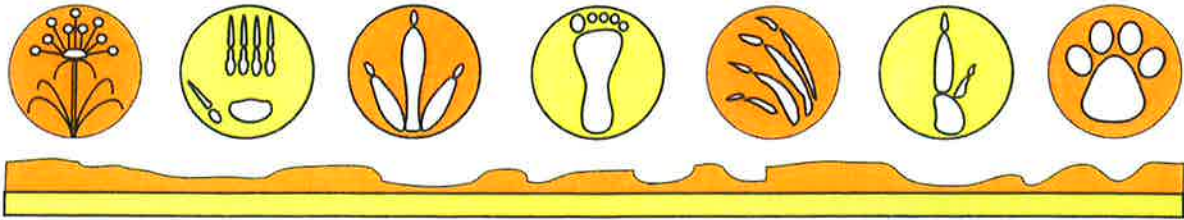

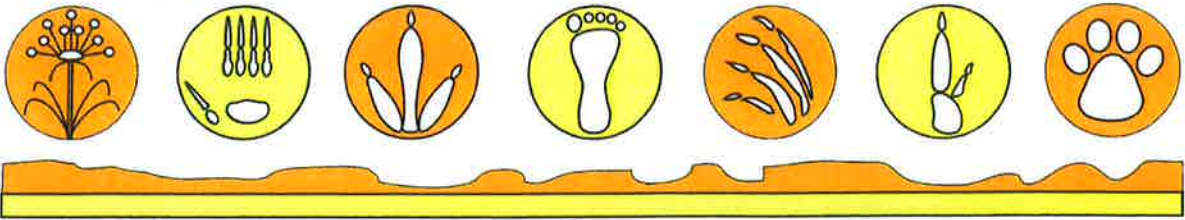

**RECOMMENDATION****That the Authority**

**SUMMARY:**

The Local Authority has been convened to discuss the BRC Council's decision to write to the Minister to remove the Tennant Creek Local Authority from the list of Local Authority's in Tennant Creek (OC263/16).

**BACKGROUND**

The Barkly Regional Council discussed the need for a Local Authority to represent the Tennant Creek Community. A majority decision was passed which instructed the Acting CEO to write to the Minister of Housing and Community Development requesting that consideration be given to removing the requirement for a Local Authority to be formed to represent the Tennant Creek Community.

**ISSUE/OPTIONS/CONSEQUENCES**

Removal of the Tennant Creek Local Authority from the list will leave the Tennant Creek Community with no local representation aside from its five elected ward councilors.

**CONSULTATION & TIMING**

Barkly Region Council awaits the Minister of Housing and Community Development's decision. The decision of the Minister of Housing and Community will constitute a full and final ruling.
