We want to empower local decision making.

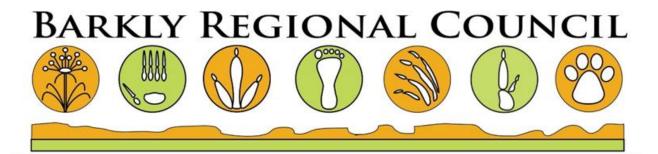
We want to ensure that our services are sustainable and that our region has a standard consistent level of services.
